NOTIFICATION

LOTTERIES (REGULATION) ACT, 1998.

No. MRL. 1008/CR-138/Lott-3.—In exercise of the power conferred by section 12 of the Lotteries (Regulation) Act, 1998 (17 of 1998) and of all other powers enabling it in this behalf, the Government of Maharashtra is hereby make the following rules to amend the Maharashtra State Lottery (Regulation) Rules, 2000, Part I, namely :—

- (1) These rules may be called the Maharashtra State Lottery (Regulation) (Amendment) Rules, 2008.
- (2) In the Maharashtra State Lottery (Regulation) Rules, 2000, Part I, rule 9 shall be deleted.
